Following are the rules and regulations governing eligibility of recipients of the Scholarship Award from the Northwest Minnesota Housing Cooperative.

In order to be eligible, applicant must be a Crookston High School graduating senior or have obtained a GED in the current academic year.

Scholarships will be awarded on the basis of:

- Potential for entering the Construction Industry in northwest Minnesota
- Character reference and other pertinent factors
- Extra-curricular activities and leadership potential
- Academic Rank

Rules:

- Scholarship recipients must attend an accredited post secondary school and be in a course of study in the areas of construction.
- One \$500 scholarship will be awarded annually in Crookston. Payment will be made directly to scholarship recipient and the school upon completion of full semester/quarter.
- All applications will be reviewed by the Scholarship Committee of Northwest Minnesota Housing Cooperative.
- Applications must be submitted within the specified deadline, which will be on March 31 to NW MN Housing Cooperative, P.O. Box 421, Thief River Falls, MN 56701
- If for any reason a recipient is unable to accept the scholarship, a replacement may be chosen.
- Northwest Minnesota Housing Cooperative reserves the right to terminate its Scholarship Program at any time, but recognizes its obligation to fulfill any scholarship agreement outstanding.

I understand acceptance of this scholarship obligates me to commence and complete the year of study contemplated in this application. I give permission to the Scholarship Committee to have the right to review my school records.
